### CONDITIONS OF CARRIAGE

- Received, subject to the classification and tariffs on the date of issue of this Original Bill of Lading, goods described above, in apparent good order, except as noted (contents and condition of contents of packages unknown), marked, consigned and destined as indicated above, which said company agrees to carry to its usual place of delivery at said destination, otherwise to deliver to another carrier on the route to said destination. It is mutually agreed, that every service to be performed hereunder shall be subject to all the terms and conditions (which are hereby incorporated by reference and have the same force and effect as if the same were severally, fully, and specifically set forth herein, General Order No. T-5, dated February 1, 1965 set forth in the Canadian Freight Classification, and of the bill of lading set forth in or prescribed by the relevant tariffs, classification, statutes and regulations pertaining to motor carrier services.
- Maximum Liability: Cdn\$2.00 per pound (Cdn\$4.41 per kilogram) per item.
- NOTICE OF CLAIM-(a) No carrier is liable for loss, damage, or delay to any goods under the bill of lading unless notice thereof setting out particulars of the origin, destination and date of shipment of the goods and the estimated amount claimed in respect of such loss, damage or delay is given in writing to the originating carrier or the delivering carrier within twenty-four (24) hours after the delivery of the goods, or, in the case of failure to make delivery, within thirty (30) days from the date of the shipment; (b) The final statement of the claim must be filed within thirty (30) days from the date of shipment together with a copy of the paid freight bill. In cases of concealed damage carrier must be notified at time of delivery. In cases of uncrated goods, carrier is not liable for any damage what so ever.
- Unless otherwise indicated freight charges will be collect. Shipper is responsible for and guarantees freight charges. Interest on unpaid freight bills of lading is 2% per month (26.8% per annum).
- Delivery slips, Cold storage receipts, et cetera, do not form part and parcel of this Bill of Lading. This Bill of Lading is the only valid document for the shipping of all freight and only the information provided on this Bill of Lading shall be binding on the shipper, consignee and the carrier.
